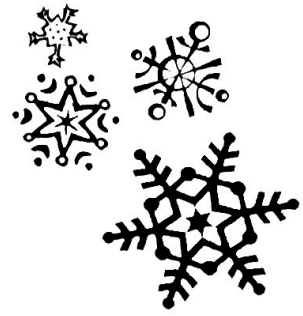

Elsinore Town Council Ordinance #196 Dogs & Cats Adopted December 20, 2019

BE RESPONSIBLE PET OWNERS – NON-PET OWNERS HAVE RIGHTS, TOO.

REMINDERS: 1. ANIMAL(S) - DOGS & CATS SHALL BE RESTRAINED OR CONFINED. ORD. 196 Section 1.F.1
2. DISTURBING THE PEACE PROHIBITED ORD. 196 Section 1. E.1. Day or Night
3. DEFECATION AND URINATION –ORD. 196 Section 1. I. – Pick-up after your dog defecates.
* 4. POSSESSION OF A VICIOUS OR AGGRESSIVE DOG(S) IS UNLAWFUL... ORD. 196 Section 2.F.1-2 – Not allowed.

Photo of your Canine/Pet is required at licensing.

• **ONLY LICENSING DOGS IN ELSINORE PROPER**
EL SINORE TOWN DOG LICENSE ANNUAL FEES ORD. 196 Sect. 2.A.j.A-E
Licensing age for Canines is 3 months and older (Large or Small Breeds)

\$35.00 PER INTACT MALE OR FEMALE

\$15.00 PER NEUTERED or SPAYED

\$ 5.00 Replacement Tag Fee

LIMIT 3 Canines per Residence **OR**

\$150.00 - 4th Dog Fee Additional Annual Fee **plus** license (ORD #196 Section 2.A.1.j.E)

\$45.00 Business License – Breeder's puppies should be sold – gone by 3 months of age.

CATS/FELINES

Please Identify your cat(s) with a collar and or I.D. tag.

No more than four (4) cats per residence

OTHER FEES – Should your dog or cat be picked up there will be:

SEVIER COUNTY POUND FEES: such as Impound, boarding, reclaim fee, adoption, late fee(s), quarantine, etc.
